

# The Ultimate Bucket List Spring Break Sweepstakes

## Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED.**

The Ultimate Bucket List Spring Break Sweepstakes (the "Sweepstakes") starts on November 1, 2016 at 12:01 AM Eastern Time ("ET") and ends on March 12, 2017 at 11:59 AM ET ("Sweepstakes Period").

**ELIGIBILITY:** Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older (or the age of majority in their state of legal residence whichever is older) as of date of entry. Employees of the National Collegiate Athletic Association ("Sponsor"), its subsidiaries, distributors, affiliates, promotion and advertising agencies, and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state and local laws.

**HOW TO ENTER:** During the Sweepstakes Period, visit <http://woobox.com/xxoh2v> and follow the instructions to complete and submit the online registration form provided to receive one (1) entry (each, an "Entry"). Entries must be received by March 12, 2017 at 11:59 AM ET to be eligible. Entries generated by script, macro or other automated means and Entries by any means which subvert the entry process are void. Limit one (1) Entry per person using only one (1) email address throughout the duration of the Sweepstakes Period. Multiple Entries received from any person ("Entrant") or e-mail address in excess of the limitation stated above will be void. All Entries become the sole property of the Sponsor and will not be returned.

**RANDOM DRAWING:** One (1) potential winner will be selected in a random drawing on or about March 12, 2017 at 10:00 PM ET from all eligible Entries received throughout the Sweepstakes Period. Odds of winning the prize will depend on the number of eligible Entries received throughout the Sweepstakes Period.

**WINNER NOTIFICATION:** Sponsor's decisions are final and binding on all matters relating to this Sweepstakes. Potential winner will be notified by mail, phone, and/or e-mail on or about March 13, 2017 and potential winner will be required to verify eligibility by executing and returning an affidavit of eligibility, a liability release, and, where lawful, a publicity release within three (3) days of date of issuance. If such documents are not returned within the specified time period, a prize or prize notification is returned as undeliverable, Sponsor is unable to contact a potential winner or a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Sponsor's discretion, an alternate winner may be selected.
